Between Fáilte Ireland and Accommodation Provider:

1 Licence

- 1.1 This is a Licence Agreement (or, to the extent that any other person licences Fáilte Ireland, a Sub Licence Agreement).
- 1.2 In consideration of your payment of the fee, Fáilte Ireland hereby licenses you to use the Fáilte Ireland name, logos and its other rights pertaining to the signs ("the Goods") made available by Fáilte Ireland to you in accordance with the terms of this Agreement.
- 1.3 The Goods are and will remain the property of Fáilte Ireland at all times and can never become your personal property and you shall not obtain any other right in the Goods beyond the terms of this Licence. You are prohibited from selling or disposing of the signs or using them otherwise than as authorised by Fáilte Ireland here under.

2. Payment

By signing this Agreement you agree to pay to Fáilte Ireland the fee by the specified dates to us at our address or to any person or address notified by us in writing to you.

3. Place Where Goods Are Kept

You must keep the Goods safely at your address and may not move them elsewhere without first obtaining our written consent.

4. Care of Goods

You shall ensure that the goods displayed will be maintained in good order at your own expense and shall insure against damage howsoever caused and will pay us the cost, including delivery, of repairing or replacing the goods. You shall ensure that any electrical installation shall be made using correct and appropriate materials and workmanship.

5. Insurance against Loss or Damage

You are responsible for all loss or damage to the Goods even if caused by acts or events outside of your control. Save with the written consent of Fáilte Ireland, you must therefore insure the Goods against loss or damage.

Termination

Without prejudice to the rights of Fáilte Ireland, we may terminate this Agreement and take back the Goods after giving you written notice if at any time:

- You fail to pay any amount within 14 days of its due date or commit any other breach of your obligations;
- You have given false information in connection with your entry into this Agreement:
- The Goods are destroyed or damaged or the insurers treat a claim under the policy for the Goods on a total loss basis;
- d. Your rating changes; or
- e. You withdraw from the Fáilte Ireland Quality Assurance Schemes.

7. Effects of Termination

- 7.1 If we terminate this Agreement you must pay us all sums due to us up to the date of termination.
- 7.2 If your property falls out of registration or renewal or ceases to participate in the Fáilte Ireland Quality Assurance Schemes you are obliged to return the signs within 30 days to Highway Safety Developments Ltd, Knocktopher, Co. KilkennyR95 TW83 or such other person as might be advised for the purpose by Fáilte Ireland and to afford all reasonable cooperation to Fáilte Ireland and its agents in connection with such recovery.

1. Licence
