

IMAGERY CONTRACT FORM

Background Information

This Model Release Form is a Contract which you and Fáilte Ireland enter. A model release form is a contract signed by individuals acting as models for still photography or digital recording.

This means that the lawful basis we use to process your personal data is 'Purpose of a Contract'.

Fáilte Ireland needs to process your personal data i.e., image, voice and/or performance for domestic and international sales and marketing for the purpose of tourism development and promotion. We will be sharing your imagery with our partner agency Tourism Ireland and others (see the table below). We will retain your personal data for a total of 7 years.

Here are some of the places that your picture and/or digital might be used

Social and Digital Media	X (formerly Twitter), Facebook, YouTube, Instagram, User Generated Content, LinkedIn, Spotify, TikTok, Snapchat, our websites and any social/digital platforms.
Media	International, national, regional, local media (TV broadcast, online, social, print, out of home, video on demand) Media partnerships, Brand Partnerships or Sponsorships
Publications	Annual reports, employee magazine or policy documents
Ireland's Content Pool	The imagery will be shared with tourism related businesses, journalistic outlets both domestically and internationally and for the third-parties' own tourism related commercial activities.
Government Agencies	The imagery will be shared with other Government Agencies, including but not limited to Tourism Ireland, OPW, Coillte, Department of Foreign Affairs, etc. for the promotion and betterment of Ireland.

Thus, the general public can copy, share and download this imagery. This means it has a global reach and so international data transfers are taking place.

Fáilte Ireland is the National Tourism Development Authority, as such the organisation promotes tourism and supports the tourism industry. The assets can only be used for the promotion of tourism.

Fáilte Ireland reserves the right to share assets with other government agencies, as set out in the table above.

This is a contractual arrangement that provides written permission to utilise an image/digital taken of that model for editorial or marketing purposes.

The assets may be requested to be used by a 3rd party for a paid advertising campaign, if this is the case you will be contacted. Please note that an agreed weighted fee structure will apply at the relevant time.

1. By signing this release I hereby give or assign my permission to Fáilte Ireland to transmit, broadcast, and publish the footage/imagery in tourism marketing activities to include but not limited to paid advertising campaigns, social media, brochure editorials, TV, websites, and, any other form of Media ("the Specified Purpose").

2. I do not object to Fáilte Ireland storing the footage/imagery for as long as necessary to fulfil the Specified Purpose or to it storing my contact details on its database in case it needs to contact me in relation to the Content.

3. Fáilte Ireland may share the footage/imagery with Tourism Ireland and such Third Parties as may be necessary to fulfil the Specified Purpose.

This is a contract you have entered into with Fáilte Ireland (Unless otherwise stated). For the purposes of Data Protection Legislation, Fáilte Ireland is the controller of the personal data comprised in the imagery/footage you have agreed to, including your contact details and any other related personal data. Definitions:

“ASSIGNS” - a person to whom the company has assigned or licensed rights under this release.

“CONTENT” - all imagery, film, audio or any other recording, still or moving taken of the model as part of the shoot.

“MEDIA” - all media including digital, electronic, print, television, film, out of home, radio and other media not known or to be invented.

“PARENT/GUARDIAN” - the Parent and/or legal Guardian of the Model.

“MODEL” means the person that has signed the contract whom has been involved in the shoot, and this includes their appearance, likeness and/or voice.

“SPECIFIED PURPOSE(s)” - means a/the reason(s) or purpose(s) to which the assets will be used for e.g. to promote Ireland as a short break destination, therefore it will not be used for commercial purposes by Fáilte Ireland.

“THIRD PARTIES” - external person and/or persons, partners, or other organisations that wish to share and use the imagery/footage for the purpose of domestic and international sales and marketing **for the purpose of tourism development and promotion.**
