



Document Requirements

Mandatory for all

- Evidence of company size
- Annual returns
- VAT Status
- Business Plan
- Proof of address
- Project Programme

- Project costs
- Match funding proof
- Evidence that the applicant is not an undertaking in difficulty
- Right to undertake

May be required

- Interpretation plan/strategy
- Planning permission
- Other statutory approvals
- Visitor experience plan
- Constitution-memo and articles of association and certificate of incorporation
- Design drawing or photos












